

TPO Invest Charges Schedule

TPO Invest offers a simplified pricing model that is inclusive of the products and services required by most investors. Fees will only be applicable once your application is accepted, and money is received into your account.

The following products and services are **included** within the TPO Invest simplified custody charge:

- General Investment Accounts;
- Individual Savings Accounts;
- Self Invested Personal Pension (SIPP) Account*;
- Third-Party asset custody services**;
- Dealing on all UK domestic funds listed on our buy list;
- Dealing on offshore funds, exchange-traded funds (ETF), investment trusts, equities, bonds and preference shares listed on our buy list, where dealing is electronically submitted and settled***.

To calculate your custody charge, the total value of your TPO Invest holdings are grouped, and an annual custody charge applied according to the following tiered rate:

- 0.23% up to £750,000
- 0.05% from £750,001 up to £3m
- No additional charge on holdings over £3m

The custody fee is calculated each month, capped at a maximum of £237.50 per month (£2,850 per annum), regardless of the number of wrappers and accounts held.

*Additional charges are applied where specialist administration is required, details of these charges can be found in the SIPP Administration Fees section on the next page.

** Third-Party asset custody availability is subject to a legal agreement between TPO Invest and the third-party provider. While TPO Invest will not levy any additional charges for the custody of investment assets, additional fees may be charged by the third-party provider.

***Additional investment assets not covered by the inclusive custody charge are outlined within our Extended Pricing schedule, which is available on request.

These charges are effective from the 1st of January 2021, and we reserve the right to change them in the future.
